Awards: Ribbons will be given to the 1st, 2nd & 3rd places in each category and division. One Best of Show will be chosen from all the entries and will receive a \$25 gift card.

Registration: Pieces can be registered on June 22 between 5pm and 10pm and on June 23 between 5pm and 10pm at the Fair Information Booth located beside shelter at the stage. If you would like to register before that day and time please call 935-5725 for drop off location and time. Artwork must be displayed in the designated area until pick up time Saturday, June 24th at 10pm. Artwork left can be picked up in the office of Poplar Gap Park Athletic Fields.

Judging: Judging will be conducted before the Fair opens and winners will be displayed in art area. All artwork must be registered by 10pm the previous day on Friday, June 23rd between 5pm & 10pm.

Rules:

- Competition is for Amateurs only ~ No Professional Quilters (defined as having a licensed quilting business or paid by a company to make quilts to be sold in stores)
- One quilt entry per category. A single quilt may not be entered into more than one category.
- Quilters may bring their own display to show quilted piece.
- All quilts must be committed for the duration of the show (Thur, June 22 – Sat, June 24) until designated pick up time (10pm Saturday-June 24th).
- Quilts must be original work pieces and be tagged with information label at time of registration.
- Judges Decisions are Final ~ No Exceptions.
